As a note of appreciation of your support for reducing paper consumption, HKEx will make charitable donation of HK\$50 for each election made by Shareholders to access Corporate Communications electronically, subject to a cap of HK\$100,000 per annum.

You are entitled at any time by reasonable notice in writing to HKEx's share registrar to change your choice of language and means of receiving Corporate Communications. If you have chosen to access Corporate Communications of HKEx using electronic means and have any difficulty in receiving or gaining access to the relevant documents, for any reason, we will promptly upon request send the printed form of the same to you free of charge.

Please note that printed English and Chinese versions of Corporate Communications of HKEx are available from HKEx or HKEx's share registrar upon request, and both versions are also available on HKEx's website and our corporate website.
