Dear Shareholders,

1. INTRODUCTION

I am pleased to invite you to the annual general meeting of the Company, which will be held at the Exchange Auditorium in the Exchange Exhibition Hall of the Stock Exchange on 1st Floor, One and Two Exchange Square, Central, Hong Kong on Thursday, 24 April 2008 at 4:30 pm. The registration of the AGM will start at 4:00 pm. In order to ensure the AGM can start on time, Shareholders or their proxies are encouraged to arrive for registration at least 15 minutes before the AGM starts.

2. BUSINESS TO BE CONSIDERED

The notice of the AGM is set out on page 5. Details of the business to be considered at the AGM, including, inter alia, (i) the election of Directors; and (ii) the renewal of the general mandate to repurchase Shares, are set forth in this circular under the "Business of Annual General Meeting".

Details relating to election of Directors, and the explanatory statement in respect of the general mandate to repurchase Shares as required by the Listing Rules, are set out in Appendix I and Appendix II of this circular respectively.

Letter from the Board of Directors

Please note that, the Board, after due and careful consideration, has decided not to propose at the AGM to grant a general mandate to the Directors to issue Shares since there is no immediate need to raise equity capital in the foreseeable future. If capital raising through an issue of Shares is required in the future, the Company will seek the necessary Shareholders' approval at the relevant time.

3. EXERCISE YOUR VOTE

Registered Shareholders

The register of members of HKEx will be closed from Monday, 21 April 2008 to Thursday, 24 April 2008, both dates inclusive, during which period, no transfer of Shares will be registered. In order to qualify for attending and voting at the AGM, all properly completed transfer forms accompanied by the relevant share certificates must be lodged for registration with HKEx's registrar, Hong Kong Registrars Limited, at Rooms 1712-1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not later than 4:30 pm on Friday, 18 April 2008. Shareholders who are on the register of members on 24 April 2008 will be entitled to attend and vote at the AGM.

Whether or not you are attending the meeting, it is important that you are properly represented and your right to vote is exercised at the meeting. I therefore encourage you to appoint a proxy to vote on your behalf if you are unable to attend in person, by completing and returning the enclosed proxy form in accordance with the instructions printed thereon to HKEx's registrar (with address shown on the cover page of this circular) as soon as possible, and in any event not less than 48 hours before the time appointed for holding the meeting. Completion and return of the proxy form shall not preclude you from attending and voting in person at the AGM or at any adjourned meeting thereof should you so wish, and the appointment of the proxy will be revoked if you vote in person at the meeting.

Non-registered Shareholders

If your Shares are held in an intermediary (for example, a bank, a custodian or a securities broker) or registered in the name of your nominee, you will not receive a proxy form. You have to give instruction to your intermediary/nominee to vote on your behalf, or if you wish to attend and vote at the AGM, you should arrange with your intermediary/nominee directly to obtain an authorisation.

4. VOTING BY POLL

As a good corporate governance practice, I intend to demand all the resolutions set out in the notice of the AGM to be decided by poll. I will explain at the meeting the detailed procedures for conducting a poll.

Letter from the Board of Directors

On a poll, every Shareholder present in person or by proxy will have one vote for every Share held. A Shareholder which is a corporation will be present in person if a duly authorised representative of such Shareholder is present at the meeting. A Shareholder present in person or by proxy who is entitled to more than one vote does not have to use all his or her votes (ie he or she can cast less votes than the number of Shares he or she holds or represents) or to cast all his or her votes the same way (ie he or she can cast some of his or her votes in favour of the resolution and some of his or her votes against the resolution). The Board believes that in most situations, Shareholders (other than nominee companies) usually cast all their votes either in favour of a resolution or against a resolution.

Procedures for demanding a poll are set out in Appendix III of this circular.

After the closure of the AGM, the poll results will be published on HKEx's corporate website at www.hkex.com.hk and the HKExnews website at www.hkexnews.hk.

5. BOARD RECOMMENDATIONS

The Board considers that the resolutions, as set out in the notice of the AGM are in the best interests of HKEx and its Shareholders as a whole, and recommends you to vote in favour of all of them at the AGM.

To consider as special business and, if thought fit, pass with or without modification the following resolution as an Ordinary Resolution:

5. **“THAT:**
 - (a) subject to paragraph (b) below, a general mandate be and is hereby unconditionally given to the Directors of HKEx to exercise during the Relevant Period (as hereinafter defined) all powers of HKEx to repurchase shares of HKEx on the Stock Exchange or on any other stock exchange on which the shares of HKEx may be listed and which is recognised by the Securities and Futures Commission and the Stock Exchange for this purpose, subject to and in accordance with all applicable laws and/or the requirements of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited or of any other stock exchange as amended from time to time;
 - (b) the aggregate nominal amount of shares which HKEx is authorised to repurchase pursuant to the mandate in paragraph (a) above shall not exceed 10 per cent of the aggregate nominal amount of the issued share capital of HKEx at the date of the passing of this Resolution, and the said mandate shall be limited accordingly; and

“Relevant Period” means the period from the passing of this Resolution until whichever is the earlier of:

- (i) the conclusion of the next annual general meeting of HKEx;

- (4) The register of members of HKEx will be closed from Monday, 21 April 2008 to Thursday, 24 April 2008, both dates inclusive, during which period, no transfer of shares will be registered. In order to qualify for the proposed final dividend, all properly completed transfer forms accompanied by the relevant share certificates must be lodged for registration with HKEx’s registrar, Hong Kong Registrars Limited, at Rooms 1712-1716, 17th Floor, Hopewell Centre, 183 Queen’s Road East, Wanchai, Hong Kong not later than 4:30 pm on Friday, 18 April 2008.
- (5) Concerning Resolution 5 of this Notice, the Board wishes to state that there are no immediate plans to repurchase any shares of HKEx pursuant to the relevant general mandate. The general mandate is being sought from shareholders in compliance with the Companies Ordinance and the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“Listing Rules”).
- (6) There will be two elected Director vacancies to be filled at the above meeting. If a shareholder wishes to nominate a person to stand for election as a Director, (i) his or her notice of intention to propose a resolution; and (ii) a notice executed by the nominated candidate of his or her willingness to be appointed together with (A) the candidate’s information as required to be disclosed under Rule 13.51(2) of the Listing Rules, and (B) the candidate’s written consent to the publication of his or her personal data, have to be validly served on the Secretary of HKEx, as early as practicable, preferably before 5:00 pm on Tuesday, 8 April 2008. Details of the foregoing are set out under Appendix I of the circular dated 26 March 2008.
- (7) As a good corporate governance practice, the Chairman intends to demand poll voting at the above meeting for all the resolutions set out in this Notice.
- (8) The registration of the above meeting will start at 4:00 pm on 24 April 2008. In order to ensure the meeting can start on time, shareholders or their proxies are encouraged to arrive for registration at least 15 minutes before the meeting starts.

Business of Annual General Meeting

ORDINARY BUSINESS

RESOLUTION 1 – RECEIVING AND APPROVING THE ANNUAL ACCOUNTS

The audited financial statements of HKEx for the year ended 31 December 2007 together with the Report of Directors, are set out in the 2007 Annual Report which is available in English and Chinese and may be downloaded from HKEx's corporate website at www.hkex.com.hk under the "Investor Relations Corner".

The financial statements have been audited by PricewaterhouseCoopers and reviewed by the Audit Committee. The reports of the Auditor and the Audit Committee are set out respectively on page 124 and pages 97 to 98 of the 2007 Annual Report.

RESOLUTION 2 – DECLARATION OF FINAL DIVIDEND

The Directors recommend a final dividend of HK\$3.40 per Share. Subject to the Shareholders' approval at the AGM, the dividend warrants will be despatched on or about 9 May 2008 to those Shareholders whose names appear on the register of members on 24 April 2008.

RESOLUTION 3 – ELECTION OF DIRECTORS

Board of Directors

The Board currently consists of 13 Directors, including:

- (i) six Directors appointed by the Financial Secretary, namely Mr Ronald J Arculli, Mrs Laura M Cha, Dr Moses M C Cheng, Dr Marvin K T Cheung, Mr Henry H L Fan and Mr Fong Hup;
- (ii) six Directors elected by Shareholders ("Elected Directors"), namely Dr Bill C P Kwok, Mr Vincent K H Lee, Dr Christine K W Loh, Mr John E Strickland, Mr David M Webb and Mr Oscar S H Wong; and
- (iii) the Chief Executive of the Company, Mr Paul M Y Chow, as an ex-officio Director.

Retiring Elected Directors

Dr Bill C P Kwok and Mr Vincent K H Lee will retire from office at the conclusion of the AGM. Pursuant to Article 93(5) of the Articles of Association, both are eligible for re-appointment.

Shareholders may, if thought fit, nominate other candidates to stand for election as a Director at the AGM to fill the vacancies arising from the retirement of these two Directors.

Recommendations of the Nomination Committee

The Nomination Committee comprising five independent non-executive Directors, namely Mr Ronald J Arculli, Mr Henry H L Fan, Mr Vincent K H Lee, Mr John E Strickland and Mr David M Webb, has nominated, and the Board has recommended Dr Bill C P Kwok and by majority, Mr Vincent K H Lee to stand for re-election as Directors at the AGM. As a good corporate governance practice, Mr Vincent K H Lee had abstained from voting at the Nomination Committee meeting when his nomination was being considered, and both Dr Bill C P Kwok and Mr Vincent K H Lee had abstained from voting at the Board meeting when their nominations were considered and approved by the Board for recommending to Shareholders.

Business of Annual General Meeting

The Nomination Committee is also responsible for, inter alia, assessing the independence of non-executive Directors. In doing so, the Nomination Committee had reviewed the individual Director's annual confirmation of independence declared pursuant to Rule 3.13 of the Listing Rules. As a good corporate governance practice, every member of the Nomination Committee had abstained from assessing his own independence. The Nomination Committee considered that Dr Bill C P Kwok and Mr Vincent K H Lee have fulfilled the definition of independence under Rule 3.13 of the Listing Rules.

Information on the retiring Elected Directors, including their biographical details, interests in Shares, attendance record at meetings of the Board and other committees and panel, and the matters relating to nominations by Shareholders are set out in Appendix I of this circular.

Regarding the resolutions under item 3 of the notice of the AGM relating to the election and re-election of Directors, Shareholders will be invited to vote on each candidate separately. An explanation of the relevant resolutions and voting procedures is also set out in Appendix I.

RESOLUTION 4 – RE-APPOINTMENT OF AUDITOR AND SETTING OF AUDITOR'S FEE

For the year ended 31 December 2007, the external auditor's fees were HK\$2,995,100 (2006: HK\$2,772,802), of which HK\$2,585,000 (2006: HK\$2,323,600) was for audit services and HK\$410,100 (2006: HK\$449,202) related to non-audit services.

The Audit Committee had reviewed the work of the auditor and the amount of its fees for the 2007 audit, and was satisfied with the independence and objectivity of PricewaterhouseCoopers and has recommended their re-appointment for the 2008 audit. PricewaterhouseCoopers have also expressed their willingness to continue in office.

The proposed resolution under item 4 of the notice of the AGM is the proposed re-appointment of PricewaterhouseCoopers as auditor and the grant of the authority to the Directors to fix auditor's remuneration.

SPECIAL BUSINESS

RESOLUTION 5 – GENERAL MANDATE TO REPURCHASE SHARES

At the annual general meeting of HKEx held on 26 April 2007, an ordinary resolution was passed to grant a general mandate to the Directors to repurchase Shares. This general mandate will lapse at the conclusion of the AGM. An ordinary resolution will be proposed at the AGM to grant to the Directors a general mandate to repurchase Shares up to an aggregate nominal amount not exceeding 10 per cent of the aggregate nominal amount of the share capital of HKEx in issue at the date of the passing of the relevant resolution (the "Repurchase Mandate").

An explanatory statement, as required by the Listing Rules to be sent to Shareholders in connection with the Repurchase Mandate, is set out in Appendix II of this circular, which contains all the information reasonably necessary to enable Shareholders to make an informed decision on whether or not to vote for or against the ordinary resolution to grant the Repurchase Mandate at the AGM.

The Board wishes to state that it has no immediate plans to repurchase any Shares pursuant to the Repurchase Mandate.

Shareholders should refer to the notice of the AGM, set out on pages 5 to 6, for details of the resolution on the Repurchase Mandate which will be considered at the AGM.

Notes:

1. This represented Mr Lee's interests in the underlying shares through listed equity derivatives (physically settled options) held by Pacific Trust Company Limited, in which Mr Lee holds 33.33 per cent beneficial interests.

2. Mr Lee was appointed on 4 December 2003 as an independent non-executive director and a member of the audit committee of Ocean Grand Holdings Limited (provisional liquidators appointed on 24 July 2006) (“OGH”) which is incorporated in Bermuda with headquarters and shares being listed, in Hong Kong. OGH is a holding company and its subsidiaries are principally engaged in the manufacturing and wholesaling of aluminum extrusion products and chemicals produced on sites located in Nanhai and Zhuhai, the People’s Republic of China and in Hong Kong for use in electroplating process.

On 22 April 2005, Mr Lee was appointed as the chairman of OGH’s audit committee and a member of its remuneration committee. Mr Lee tendered his resignation from the OGH board for personal reasons on 21 July 2006, which was received by OGH on 24 July 2006, the same day on which OGH announced that provisional liquidators were appointed pursuant to the Order of the High Court in Hong Kong of even date given upon application by the OGH board for protection of OGH’s assets and safeguard of creditors’ and shareholders’ interests.

As announced by OGH on 11 July 2006, during the conduct of the audit for the fifteen-month period ended 31 March 2006, certain issues were highlighted by the auditors including the potential accounting irregularities relating to a wholly-owned subsidiary of OGH on the Mainland. As a result, the audit committee chaired by Mr Lee engaged forensic accountants to enquire into the business dealings. The estimated impact on OGH’s financial results due to the potential accounting irregularities might exceed RMB6 million.

On 24 July 2006, OGH further announced that the aggregate of bank balances of certain operating subsidiaries of OGH on the Mainland as at 20 July 2006 confirmed by forensic accountants was approximately RMB38 million compared with approximately RMB880 million as stated in the management accounts as at 31 March 2006. The discrepancy has been reported to the local police.

On 28 November 2006, the provisional liquidators announced that there had been apparently a falsification of accounting records and documents of the major operating subsidiaries of OGH on the Mainland resulting in significant shortfall in the realisable value of OGH’s assets. Following reports on accounting irregularities uncovered by the provisional liquidators, the Commercial Crime Bureau of the Hong Kong Police Force had conducted a number of searches of OGH’s premises, seized documents and records, and was still investigating the case. Two members of the OGH’s nine-member board were arrested, including OGH’s chairman, who has been charged with conspiracy to defraud and conspiracy to steal. The cases are pending trial.

On 20 July 2006, a writ of summons was issued in the High Court in Hong Kong against OGH and certain subsidiaries by Bank SinoPac claiming the payment of a sum of HK\$6,396,081.12 together with interest.

On 15 November 2006, a writ of summons was issued in the High Court in Hong Kong against a wholly-owned subsidiary of OGH by Banca Di Roma claiming sums of US\$3,295,458.04, HK\$7,414,225.65 and HK\$26,282.73 together with interest and costs.

On 23 August 2007, upon application of OGH and three of its wholly-owned subsidiaries (collectively “Plaintiffs”), a writ of summons was filed and issued in the High Court in Hong Kong naming 15 defendants including each and every director of OGH (collectively “Defendants”), claiming against each of them for damages or equitable compensation in respect of all loss and damage suffered by the Plaintiffs in the sum of HK\$111,150,074 together with interest and costs as a result of breaches of statutory, regulatory, fiduciary, contractual, tortious or other duties; breaches of contracts of employment and duty of fidelity; breaches of trust; misstatements or misleading statements by, and negligence of, the Defendants in the course of or in connection with a contract dated 1 November 2005 (“Writ”). Mr Lee has confirmed to HKEx that the Writ has not been served on him and he has therefore not been called upon or had the opportunity to defend these proceedings.

On 12 March 2008, the Stock Exchange announced that, effective from the date of the announcement, OGH will be put into the third stage of the delisting procedures, pursuant to which, OGH will be given a final period of six months for the submission of a viable resumption proposal to the Stock Exchange. Otherwise, the listing of OGH will be cancelled on the expiry of the six months from the date of the announcement, ie 12 September 2008.

Mr Lee has stated to HKEx that he believes that he properly and fully discharged his duties as a director of OGH and is confident that the Writ proceedings, if served on him, would fail.

Relationship with other Directors, senior management and substantial/controlling shareholders

Neither Dr Bill C P Kwok nor Mr Vincent K H Lee is related to other Directors, senior management, substantial shareholders (as defined in the Listing Rules), or controlling shareholders (as defined in the Listing Rules) of HKEx.

Neither Dr Bill C P Kwok nor Mr Vincent K H Lee has any service contract with any member of the HKEx group.

Save for the information disclosed above, there is no other information required to be disclosed pursuant to any of the requirements of Rule 13.51(2) of the Listing Rules or to be brought to the attention of Shareholders in respect of the Directors who stand for re-election at the AGM.

Nominations by Shareholders

Shareholders are invited to elect up to two Directors at the AGM to fill the vacancies available due to the retirement of the two said Elected Directors. According to Article 90(1A) of the Articles of Association, the two Directors to be elected at the AGM will be appointed for a term of not more than approximately three years expiring at the conclusion of the Company's annual general meeting to be held in 2011.

Article 90(2) of the Articles of Association provides that no person (other than a Director retiring in accordance with the Articles of Association) shall be appointed or re-appointed as an Elected Director at any general meeting unless:

- (a) he or she is recommended by the Directors; or
- (b) not earlier than the day after the despatch of the notice of the meeting and not later than seven days prior to the date appointed for the meeting there has been given to the Secretary of the Company, by a Shareholder (other than the person to be proposed) entitled to vote at the meeting, notice of his or her intention to propose a resolution for the appointment or re-appointment of that person and a notice executed by that person of his or her willingness to be appointed or re-appointed.

Accordingly, if a Shareholder wishes to nominate a person to stand for election as a Director, the following documents must be validly served on the Secretary of the Company, namely (i) his or her notice of intention to propose a resolution; and (ii) a notice executed by the nominated candidate of his or her willingness to be appointed together with (A) the candidate's information as required to be disclosed under Rule 13.51(2) of the Listing Rules and other information, as referred to under the heading "Requisite information of the candidate(s) nominated by Shareholders" below, and (B) the candidate's written consent to the publication of his or her personal data.

In order to ensure Shareholders have sufficient time to receive and consider the information on the nominated candidate(s), Shareholders are urged to submit their proposals as early as practicable, preferably before 5:00 pm on Tuesday, 8 April 2008 so that a supplemental circular containing information on the candidate(s) proposed by Shareholders can be despatched to Shareholders, and an announcement can be issued on or about 9 April 2008.

Requisite information of the candidate(s) nominated by Shareholders

In order to enable Shareholders to make an informed decision on their election of Directors, the said notice of intention to propose a resolution by a Shareholder should be accompanied by the following information on the nominated candidate(s):

- (a) full name and age;
- (b) positions held with HKEx and/or other members of the HKEx group (if any);
- (c) previous experience including other directorships in listed public companies in the last three years and other major appointments and qualifications;
- (d) current employment and such other information (which may include business experience, professional qualifications and educational background) of which Shareholders should be aware of, pertaining to the ability or integrity of the candidate;
- (e) length or proposed length of service with HKEx;
- (f) relationships with any Directors or senior management of HKEx, or an appropriate negative statement;
- (g) interests in Shares within the meaning of Part XV of the SFO, or an appropriate negative statement;
- (h) a declaration made by the nominated candidate in respect of the information required under Rule 13.51(2)(h) to (w) of the Listing Rules, or an appropriate negative statement to that effect where there is no information to be disclosed pursuant to any of such requirements nor there are other matters that need to be brought to the attention of Shareholders; and
- (i) contact details.

The Shareholder proposing the candidate will be required to read out aloud the proposed resolution, as set out under “Resolutions and Voting” below, at the AGM.

RESOLUTIONS AND VOTING

In order to comply with section 157A of the Companies Ordinance and Article 91 of the Articles of Association, there must be a separate resolution for the appointment of each candidate, unless a resolution that a single resolution for the appointment of two or more candidates shall be proposed has been first agreed to by the meeting without any vote being cast against it. There will be two Elected Directors vacancies to be filled at the AGM. In the case if there are more than two candidates standing for election, then in order to select which two candidates as the Elected Directors, the resolutions themselves will contain a method of determining support for a candidate. Each resolution to be proposed at the AGM will provide as follows:

“THAT subject to the number of net votes cast in relation to this resolution (net votes being votes cast in favour minus votes cast against this resolution) being among the two highest number of net votes cast on each of the resolutions for the appointment of a person as a director of the Company at the annual general meeting to be held on 24 April 2008 or on the date of its adjournment (where applicable) (the “2008 AGM”), [name of candidate] be and is hereby appointed as a director of the Company with effect from the conclusion of the 2008 AGM for a term of approximately three years expiring at the conclusion of the Company’s annual general meeting to be held in 2011, provided that if any two or more of such resolutions record the same number of net votes (the “Tied Resolutions”), the ranking of the Tied Resolutions from highest to lowest number of net votes shall be determined by the drawing of lots by the chairman of the meeting.”

If a resolution is passed (ie it has been carried by a majority of the votes cast on it), the candidate who is the subject of that resolution will be eligible to be elected a Director. On the other hand, if a resolution is not passed, the candidate who is the subject of that resolution will not be eligible to be elected a Director. If there are less than two resolutions passed by a majority of the votes cast, the Board may appoint any person to fill the vacancy pursuant to Article 92 of the Articles of Association.

Assuming a resolution is passed by a majority of the votes cast on it, the candidate who is the subject of that resolution will be elected to one of the two positions on the Board if the net votes cast in favour of his or her resolution rank within the top two resolutions passed in terms of net votes. Net votes are calculated by taking the votes cast in favour of a resolution and subtracting the votes cast against that resolution. In the event there is a tie in the net votes for two or more resolutions, the tie will be resolved by the drawing of lots by the chairman of the meeting.

Therefore, if you wish to support a particular candidate, you should vote in favour of his or her resolution. If you do not wish to support a candidate, you may vote against his or her resolution or abstain from voting. If you abstain from voting, you should note that your votes will not be counted when calculating the net votes in relation to that candidate.

This Appendix serves as an explanatory statement required to be sent to Shareholders under the Listing Rules in connection with the proposed Repurchase Mandate and also constitutes the memorandum required under section 49BA of the Companies Ordinance.

1. THE LISTING RULES

The Listing Rules permit a company with a primary listing on the Stock Exchange to repurchase its securities on the Stock Exchange subject to certain restrictions, the most important of which are summarised below:

(a) Shareholders' approval

The Listing Rules provide that all proposed repurchases of securities by a company with a primary listing on the Stock Exchange must be approved in advance by an ordinary resolution, either by way of a general mandate or by specific approval of a particular transaction.

Such authority may only continue in force during the period from the passing of the resolution until whichever is the earlier of: (i) the conclusion of the next annual general meeting of the company, (ii) the expiration of the period within which the next annual general meeting of the company is required by law to be held, or (iii) the passing of an ordinary resolution by shareholders in general meeting of the company revoking or varying such mandate.

(b) Source of funds

Repurchases must be funded out of funds legally available for such purpose. A listed company may not repurchase its own securities on the Stock Exchange for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange.

(c) Trading restrictions

The shares proposed to be repurchased by a company must be fully paid up. A maximum of 10 per cent of the issued share capital of a company as of the date of resolution passed on the grant of a repurchase mandate may be repurchased on the Stock Exchange. A company may not issue or announce an issue of new shares for a period of 30 days immediately following a repurchase (other than an issue of securities pursuant to an exercise of share options or similar instruments requiring the company to issue securities which were outstanding prior to such repurchase) without the prior approval of the Stock Exchange (or in the case of HKEx, the SFC). In addition, a company shall not repurchase shares on the Stock Exchange if the purchase price is higher by 5 per cent or more than the average closing market price for the five preceding trading days on which its shares were traded on the Stock Exchange. The Listing Rules also prohibit a company from repurchasing its own securities on the Stock Exchange if the repurchase would result in the number of that company's listed securities which are in the hands of the public falling below the relevant prescribed minimum percentage as required by the Listing Rules.

(d) Status of repurchased securities

The Listing Rules provide that the listing of all repurchased securities is automatically cancelled and that the certificates for those securities must be cancelled and destroyed. The aggregate of the authorised share capital shall remain unchanged.

(e) Suspension of repurchases

The Listing Rules prohibit any repurchase of securities at any time after a price sensitive development has occurred or has been the subject of a decision until such time as the price sensitive information is made publicly available. In particular, a company may not repurchase securities on the Stock Exchange, unless the circumstances are exceptional, during the period of one month immediately preceding the earlier of (i) the date of the board meeting for the approval of the company's results for any year, half-year, quarterly or any other interim period and (ii) the deadline for the company to publish an announcement of its results for any year or half-year under the Listing Rules, or quarterly or any other interim period, and ending on the date of the results announcement. In addition, the Stock Exchange (or in the case of HKEx, the SFC) reserves the right to prohibit repurchases of securities on the Stock Exchange if a company has committed a breach of the Listing Rules.

(f) Reporting requirements

Under the Listing Rules, repurchases of securities on the Stock Exchange or otherwise must be submitted for publication to the Stock Exchange (or in the case of HKEx, the SFC and the Stock Exchange) by not later than 9:00 am (Hong Kong time) on the following business day. In addition, a company's annual report is required to disclose details regarding repurchases of securities made during the year including the number of securities repurchased each month, the repurchase price for each such securities or the highest and lowest price paid for each repurchase where relevant, and the aggregate price paid for such repurchases and the reasons of the directors of the company for making such repurchases.

A company shall procure that any broker appointed by the company to effect the repurchase of securities shall disclose to the Stock Exchange (or in the case of HKEx, the SFC) such information with respect to repurchases made on behalf of that company as the Stock Exchange (or in the case of HKEx, the SFC) may request.

(g) Connected parties

The Listing Rules prohibit a company from knowingly repurchasing securities on the Stock Exchange from a "connected person", that is, a director, chief executive or substantial shareholder of the company or any of its subsidiaries or their respective associates (as defined in the Listing Rules) and a connected person is prohibited from knowingly selling his securities in the company back to the company. No connected person (as defined in the Listing Rules) has notified HKEx that he has a present intention to sell Shares to HKEx, or has undertaken not to do so, if the Repurchase Mandate is exercised.

2. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of HKEx comprised 1,071,274,346 Shares. Subject to the passing of the ordinary resolution approving the Repurchase Mandate and on the basis that no further Shares are issued or repurchased following the Latest Practicable Date and up to the date of the AGM, exercise in full of the Repurchase Mandate could accordingly result in up to 107,127,434 Shares being repurchased by HKEx during the period from the date of the AGM up to (i) the conclusion of the next annual general meeting of HKEx, (ii) the expiration of the period within which the next annual general meeting of HKEx is required by law to be held, or (iii) the passing of an ordinary resolution by Shareholders in general meeting of HKEx revoking or varying the Repurchase Mandate, whichever occurs first.

3. REASONS FOR REPURCHASES

The Board believes that it is in the best interests of HKEx and its Shareholders to have a general authority from Shareholders to enable HKEx to repurchase Shares in the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of HKEx and/or its earnings per Share and will only be made when the Board believes that such repurchases will benefit HKEx and its Shareholders.

4. FUNDING OF REPURCHASES

In repurchasing securities, HKEx may only apply funds legally available for such repurchase in accordance with its Memorandum and Articles of Association, the laws of Hong Kong and the Listing Rules. Repurchases pursuant to the Repurchase Mandate will be made out of funds of HKEx legally permitted to be utilised in this connection, including the funds of HKEx otherwise available for dividend or distribution or the proceeds of a fresh issue of shares made for such purpose. Any premium payable on a repurchase over the par value of the Shares to be repurchased must be provided for out of funds of HKEx otherwise available for dividend or distribution or out of sums standing to the credit of HKEx's share premium account.

There might be a material adverse effect on the working capital or gearing position of the HKEx group of companies, as compared with the position disclosed in the audited accounts contained in the annual report of HKEx for the year ended 31 December 2007, in the event that the Repurchase Mandate is exercised in full at any time. However, the Board does not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the HKEx group of companies or its gearing levels which, in the opinion of the Board, are from time to time appropriate for HKEx.

5. GENERAL

None of the Directors nor, to the best of their knowledge, having made all reasonable enquiries, their respective associates (as defined in the Listing Rules), have any present intention, if the Repurchase Mandate is exercised, to sell any Shares to HKEx or its subsidiaries.

The Board has undertaken to the SFC that, so far as the same may be applicable, it will exercise the Repurchase Mandate only in accordance with the Listing Rules and the applicable laws of Hong Kong.

If as a result of a repurchase of Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of HKEx increases, such increase will be treated as an acquisition of voting rights for the purposes of the Takeovers Code. Accordingly, a Shareholder or a group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase in the Shareholders' interest, could obtain or consolidate control of HKEx and thereby become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code. Save as aforesaid, the Board is not aware of any consequences which would arise under the Takeovers Code as a result of any repurchases of Shares pursuant to the Repurchase Mandate.

6. SHARE REPURCHASES MADE BY HKEX

HKEx has not repurchased any Shares during the six months prior to the Latest Practicable Date (whether on the Stock Exchange or otherwise).

7. SHARE PRICES

During each of the previous 12 months preceding the Latest Practicable Date, the highest and lowest prices at which the Shares were traded on the Stock Exchange were as follows:

Pursuant to Article 70 of the Articles of Association, a resolution put to the vote at a general meeting shall be decided on a show of hands unless (before or upon the declaration of the result of the show of hands) a poll is demanded by:

- (i) the chairman of the meeting; or
- (ii) at least three members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy having the right to vote on the resolution; or
- (iii) a member or members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy representing in aggregate not less than one-tenth of the total voting rights of all the members having the right to attend and vote at the meeting; or
- (iv) a member or members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy holding Shares conferring the right to attend and vote at the meeting on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all the Shares conferring that right.

Unless a poll is so demanded (and the demand is not withdrawn), a declaration by the chairman of the meeting that a resolution, on a show of hands, has been carried, or carried by a particular majority, or lost, or not been carried by a particular majority, shall be conclusive, and an entry to that effect in the books of proceedings of HKEx shall be conclusive evidence thereof, without proof of the number or proportion of the votes recorded in favour of or against such resolution.

The result of the poll shall be deemed to be a resolution of the meeting at which the poll was demanded.
