You are entitled at any time by reasonable notice in writing to HKEx's registrar or by email to HKEx at communicationrequest@hkex.com.hk to change your choice of language or means of receiving Corporate Communications. If you have elected to access HKEx's Corporate Communications using electronic means but for any reason have any difficulty in receiving or gaining access to the relevant documents, our registrar will promptly upon request send the printed form of the same to you free of charge.

Please note that printed English and Chinese versions of HKEx's Corporate Communications are available from HKEx or HKEx's registrar upon request, and both versions are also available on the HKEx website and HKExnews website at www.hkexnews.hk.
