Forfeiture of Unclaimed Final Dividend for 2006

Pursuant to the Articles of Association of Hong Kong Exchanges and Clearing Limited (“HKEx”), the unclaimed final dividend for 2006 will be forfeited and will revert to HKEx on 8 May 2013.
