Even if you have elected (or are deemed to have elected) to access the Corporate Communications by electronic means through the HKEx website ("Electronic Version") but for any reason have difficulty in accessing the relevant Corporate Communication electronically, or wish to receive printed copies, HKEx will promptly upon receiving your request send the printed form to you free of charge.

You are encouraged to elect the Electronic Version which helps conserve the environment, and we believe that it is also the most prompt, efficient and convenient method of communication with Shareholders. Should Shareholders elect the Electronic Version, HKEx will donate HK\$50 to a charity with a focus on environmental protection, subject to a cap of HK\$100,000 per annum.
