We are pleased to enclose HKEX's 2024 Interim Report (in both English and Chinese) for your attention.

Pursuant to the Listing Rules, the Hong Kong Companies Ordinance and HKEX's Articles of Association, HKEX supplies Corporate Communications (other than Actionable Corporate Communications) (Note 1) to shareholders by electronic means through the HKEX Group website (<u>www.hkexgroup.com</u>) and the HKEXnews website (<u>www.hkexnews.hk</u>) ("Electronic Version"), provided that shareholders have consented to receiving the Electronic Version.

Please submit your request by completing the Online Request Form via the QR code above or the Request Form available for download from the HKEX Group website (www.hkexgroup.com) (Note 2) should you wish to:

- only receive email notification of the posting of Corporate Communication(s) on the HKEX Group website in the future: or
- receive Corporate Communications issued by HKEX (up to the time when HKEX publishes its next annual report in the following year) in printed form ("Printed Version") $^{(Note\ 3)}$. (b)

If HKEX does not receive the duly completed request form opting for the Printed Version by 3 October 2024, you are deemed to have elected the Electronic Version, and a notification of the posting of Corporate Communication(s) on the HKEX Group website will be sent to you in the future (Note 4).

You may at any time change your choice of language or means of receipt of Corporate Communications with not less than seven days' notice in writing to Hong Kong Registrars Limited, by submitting the Online Request Form or the Request Form (Notes 2 and 3).

All Corporate Communications are available on the HKEX Group website and the HKEXnews website. If you have difficulty in accessing the relevant Corporate Communications electronically and wish to receive printed copies, HKEX will promptly upon your request send the Printed Version to you free of charge.

- Notes:
 Corporate Communication refers to any document issued or to be issued by HKEX for the information or action of holders of any of its securities, including, but not limited to, the directors' report and annual accounts together with a copy of the auditor's report, the interim report, a notice of meeting, a listing document, a circular and a proxy form.
 - Actionable Corporate Communication refers to any corporate communication that seeks instructions from an issuer's securities holders on how they wish to exercise their rights or make an election as the issuer's securities holders. For the avoidance of doubt, this does not include a notice of general meeting or proxy form. Pursuant to the Listing Rules and the Hong Kong Companies Ordinance, HKEX will send the Printed Version of the Actionable Corporate Communications to holders of its securities individually.
- You may complete and submit the Request Form, which is available for download from the Investor Relations (Shareholder Services) section on the HKEX Group website (www.hkexgroup.com), to Hong Kong Registrars Limited, by post to 17M Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong, or by email to hkex.ecom@computershare.com.hk.
- HKEX will seek shareholders' consent to receiving the Electronic Version of Corporate Communications (other than Actionable Corporate Communications) annually at the time when the annual report is published. If, after HKEX's publication of its annual report, you submit a request for the Printed Version of future Corporate Communications issued by HKEX according to the instructions stated above, you will be provided with printed copies of all Corporate Communications issued by HKEX after the date of your request and up to the time when HKEX publishes its next annual report in the following year.
- The notification will be sent to you by email or, if no email address is provided, by post to your address as it appears in HKEX's register of members.
