New Arrangement for Dissemination of Corporate Communications

Pursuant to the Listing Rules, the Hong Kong Companies Ordinance and HKEX's Articles of Association, HKEX will continue to disseminate its Corporate Communications electronically through the HKEX Group website (www.hkexgroup.com) and the HKEXnews website (www.hkexnews.hk). HKEX will only send Corporate Communication(s) in printed form to non-registered shareholders, upon their request.

Shareholders are recommended to access the English and/or Chinese version(s) of HKEX Corporate Communications through the relevant links provided in the Investor Relations (Regulatory Disclosure) section of the HKEX Group website or through browsing the HKEXnews website (under HKEX's stock code "388" or "80388").

HKEX will no longer notify non-registered shareholders by post upon publication of Corporate Communications electronically. If you would like to be notified when HKEX publishes its Corporate Communications on the HKEX Group website, you may register for the News Alerts service in the Market Data section of the HKEX Market website (www.hkex.com.hk) or submit your request for receiving email notification of the publication by liaising with your Intermediary(ies) (Note 3) and providing them with your email address. Please ensure that your email address provided is valid and functional.

Request for printed or electronic version of Corporate Communication(s)

Please note that your request, if any, for receiving future Corporate Communications of HKEX in printed form will only be valid from the date of your request and until the time when HKEX publishes its next annual report in the following year, unless your instruction is earlier revoked or superseded.

Please complete and submit the Online Request Form via scanning the QR code above or the Request Form (Note 4) should you wish to:

- (a) request for printed version of HKEX's future Corporate Communications, or amend or cancel your prior request; or
- (b) receive a printed or electronic version of the HKEX 2025 Interim Report or other relevant Corporate Communication after you have encountered difficulty in accessing the document electronically via the HKEX Group website or the HKEXnews website.

You may at any time make, amend or cancel your request for printed version of future Corporate Communications with not less than seven days' notice in writing to HKEX's registrar, Computershare Hong Kong Investor Services Limited ("Share Registrar"), by submitting the Online Request Form or the Request Form (Note 4). HKEX will promptly upon your request send the printed or electronic version to you free of charge.

If you have sold or transferred your shares in HKEX, please disregard this letter.

Corporate Communications refer to any documents issued or to be issued by HKEX for the information or action of holders of any of its securities or the investing public, including, but not limited to, the directors' report, the annual accounts together with a copy of the auditor's report, the interim report, a notice of meeting, a listing document, a circular and a proxy form.
